Note:

- Candidates, who have already acquired COC as Dredge Mate Gr. I /2nd Mate (FG) /NWKO(NCV)and also who are about to obtain the said COC are not eligible to apply for DNS cadet.
The period of onboard training will be 21 months for Dredge Cadets. The training may be extended /curtailed based on the Corporation's/ DG Shipping requirement.

B. Selection Methodology

➤ **For the Trainee posts viz. Dredge Cadets**

- The selection is based on the percentage of marks obtained in the prescribed qualification mentioned above and performance in Interview for Dredge Cadets
- Filling up of vacancies is solely at the discretion of the Management based on suitability of candidates and no claim will arise for appointment, if vacancies are not filled due to unsuitability/insufficient number of candidates/any other reason what-so-ever.
- The candidature of the applicant would be provisional and subject to subsequent verification of certificates/testimonials.
 - **For 1st class Inland Master/2nd class Inland Master**
- The selection is based on performance in Interview

C. Stipend/ Pay:

For Dredge Cadets:

- During the training period Dredge Cadets will be paid stipend of Rs.15000/- per month plus victualling allowance @Rs.600 per day Candidates selected as Dredge Cadets will have to execute a Bank guarantee of three lakhs or the same amount to be deposited with DCI to serve DCI for a period of five years after completion of requisite training period and obtaining CoC
- **For 1st class Inland Master/ 2nd class Inland Master** : wages are negotiable

D. General Instructions

- Candidates applying for Dredge Cadets should possess requisite valid Indian CDC, Passport, INDOS and basic STCW'2010 Certificates.
- Candidates belonging to SC/ST/OBC/EWS category should bring the caste certificate as per the pro-forma of Govt. of India [Annexure- A (SC/ST) and Annexure-B(OBC), Annexure-D (EWS)]. For candidates belonging to OBC category, the Community Certificate should not be more than one year old and should, among others, specifically mention that person does not belong to a creamy layer. A self declaration to that effect shall be submitted by the OBC candidate in addition to the Community certificate (Annexure-C).
- Candidates belonging to EWS category should produce a valid Income and Asset Certificate issued by any of the following authorities in the prescribed format as given in Annexure-D. This certificate shall only be accepted as proof of candidate's claim as belonging to EWS, failing which their candidature will not be considered against reservation under EWS category: District Magistrate/Additional District Magistrate/ Collector/ Deputy Commissioner/Additional Deputy Commissioner/ 1st Class Stipendary Magistrate/ Sub-Divisional Magistrate/ Taluka Magistrate/ Executive Magistrate/ Extra Assistant Commissioner/ Chief Presidency Magistrate/Additional Chief Presidency Magistrate/ Presidency Magistrate / Revenue Officer not below the rank of Tahsildar and Sub-Divisional Officer or the area where the candidate and/or his family normally resides.
- Applications without supporting documents or incomplete, in any aspect, or not fulfilling the prescribed criteria shall be summarily rejected during walk-in –interview.
