- 18. The disputes, if any arising between the vendor and DCIL shall be resolved in the jurisdiction of court at Vishakhapatnam.
- 19. The Transporter is responsible to clear the materials through the check posts and toll gates with his own expenses.
- 20. Over dimension charges will paid by DCIL upon submitting the original receipts along with the Invoice.
- 21. Detention Charges will paid by DCIL based on the remarks on the acknowledgement issued at the delivery location of the concerned DCIL representative.
- 22. Vehicles placed should have valid insurance, RC, pollution, fitness certificates etc. Part load is not allowed. Port entry pass amount is inclusive.
- 23. The Vehicle, Driver, Labour should have valid RFID passes issued by local concerned Port Authority, during the time of engaging the vehicle for in and out purpose. DCIL is not responsible for these permissions.



- 24. The drivers, labours engaged by the Transporter should be followed port safety rules & regulations and personal protection suit (PPS):
- 25. After award of work order, if the supplier fails to complete in full within the prescribed delivery period, then the corporation reserves the right for following:
- a. To recover from the supplier, liquidated damages and not by way of penalty, a sum not less than 1% of the value of order or portion thereof which the supplier failed to deliver the material as aforesaid, for each day or part of a day subject to maximum of 10% of basic, material cost during which the completion of such order may be in arrears.
- b. To cancel the order or portion thereof, and if so decided, to process a fresh order on alternative sources at the risk and cost of the supplier. The manner and method of such purchase shall be in entire is creation of the Corporation.
- c. The Rate indicated are inclusive of Door Collection of Materials from consigner and Door Delivery to the Consignee basis.
- d. The transport contractor is required to place the truck at place as indicated by M/s DCIL, Kolkata / Haldia Office within 12 hours on issuance of work order or intimation over telephone or email, for collection of materials. However, transporter is in a position to place the vehicle within short notice also, due to emergency / exigency of work in nature.

### 26. Amendment of Bidding Documents:

- a. At any time prior to the deadline for submission of bids, the DCI may, for any reason, whether at its own initiative or in response to a clarification requested by prospective bidder, modify the Bidding Documents by amendment.
- b. The amendment will be notified in writing or by mail to all prospective Bidders, which have received the Bidding Documents and will be binding on them.
- c. In order to afford prospective Bidders reasonable time in which to take the amendment into account in preparing their bids, the DCI may, at its discretion, extend the deadline for the submission of bids.
- 27. The bidders shall give an undertaking that they have not made any payment or illegal gratification to any person / authority connected with the bid process so as to influence the bid process and have not committed any offence under the prevention of corruption act in connection with the bid.
- 28. The bidders shall disclose any payments made or proposed to made to any intermediaries (agents etc.) in connection with the bid.
- 29. The Corporation reserves all rights to accept or reject any tender in part or in full without assigning any reason thereof.



- 30. All matters of disputes shall be governed by the Indian Arbitration Act 1996. Any disputes arising out of this shall be subjected to Visakhapatnam Jurisdiction only.
- 31. All the statutory obligations not specified above but which are supposed to be fulfilled by the bidder including Environmental Pollution Control norms, as required to be followed, are included in the contract for its fulfilment and therefore, the agent shall keep DCI indemnified for all the consequences in case of default reported by any statutory agency.
- 32. The successful bidder shall comply with all applicable State & Central laws, statutory rules, regulations, etc.
- 33. The DCIL, Kolkata reserves the right to accept or reject any offer or withdraw tender without assigning any reason
- Arbitration: In the event of any dispute and/or difference arising between the Purchaser /Buyer and/or their Agent/Seller as to the construction, interpretation and or execution of the contract and/or execution of the contract and/or the respective rights and liabilities of the parties, such disputes and/or differences shall be referred to the Sole Arbitration of the Chief Executive of the Principal for a Company registered under the Companies Act.
