SCOPE OF WORK

I. Comprehensive Annual Maintenance Contract (CAMC) of Fire Alarm System at DCI, Dredge House, Port Area, Visakhapatnam-1. The system consists of following equipment.

II. The tenderer has to attend periodical maintenance of the system/ related equipment once in 03 months and any replacement/ repairs are to be carried out within 24 hours of lodging the complaint.

III. During the periodical maintenance, every smoke/heat detector, MCP, Hooters, etc, have to be checked for its functioning practically by creating smoke/heat, etc. and the same has to be recorded in a register.

IV. While attending quarterly periodical maintenance, mock exercise has to be conducted with our employees and demo of functioning/ operation of fire alarm system has to be carried out in batches.

V. To depute your service personnel during mock drill/ fire fighting exercises as and when required.

VI. Any part / item damaged / failed functioning has to be replaced during the contract period.

VII. To attend any number of break down calls within two to three hours' time from the intimation during the contract period.

SECTION-III GENERAL AND SPECIAL CONDITIONS OFCONTRACT

- Tenderers shall submit their tender duly indicating on the tender cover as "Tender for CAMC of Fire Alarm System – Tenderer No. DCI/HR/Elect/Fire Alarm/2019 dated 17.07.2019 and submit their tender on or before 1500 hrs. on 30.07.2019
- 2. The technical bids will be opened at 1530 hour on the due date (i.e.30.07.2019) in presence of such tenderers/representatives who are present at that time.
- 3. Tenders received after specified time and date shall not be accepted.
- 4. Towards security deposit for the due fulfilment of this contract, amount as stated in memorandum shall have to be deposited online before award of the work by the L-1 tenderer.
- 5. All tenders must be absolutely clear, failing which the same shall not be considered.
- 6. All columns would be properly and legibly filled in. No column would be left blank. Any correction in the rates etc., would be duly attested by the tenderer. Alterations, if any, not authenticated with attestation may result in rejection of the tender.
- 7. Rates quoted by the tenderer in item rate tender in figures and words will be accurately filled in, so that there is no discrepancy in the rates written in figures and words.
- 8. Special care should be taken to write the rates in figures as well as in words and the amounts in figures only, in such a way that the interpolation is not possible. The total amount would be written both in figures and in words. In case of figures word Rs. would be written before the figures of rupees and word paisa after decimal figures viz. Rs.2.15ps. and in the case of words, the word rupees should precede and the word paisa would be written at the end. Unless when rate is in whole rupee and followed by the words only, it would be invariably be up to two decimal places.
- 9. The rate will be quoted in decimal coinage and will be noted in words and figures. The amount for each item would be worked out and requisite total given.
- 10. If the amount of an item is not worked out the tenderer, it does not correspond with the rate written either in figures or in words, then the rate quoted by the tenderer in words will be taken as correct.
- 11. Where the rate quoted by the tenderer in figures and words tallies but the amount is not worked out correctly, the rate quoted by the tenderer will be taken as correct and not the amount.
- 12. Item rate tenderer bearing any inscription either to increase or decrease the quoted, rates they will not be considered and such tender will be rejected summarily.
- 13. The tenderer should sign all pages of the tenderer documents including schedule attached with the tender while tendering for the work.
- 14. The rate quoted in the tender will remain firm during the currency of contract including the extended period if any. Escalation on any account is not admissible.
- 15. The rates would inclusive of all taxes, etc.
- 16. When a tenderer signs a tender in an Indian language, the rates and the total amount tendered would also be written in the same language. In the case of illiterate contractors, the rates or the amounts tendered would be attested by witness.
- 17. GST or any other taxes in respect of this contract will be payable by the tenderer and Dredging Corporation of India limited will not entertain any claim whatsoever in this respect.
- 18. The tender should be valid for a period of 90 days (ninety) from the date of opening
- 19. DCI reserves the right to cancel/withdraw the tender at any stage without assigning any reason.
- 20. Conditional tenderer and additional of the tenderer will not be considered.

- 21. In the event of any breach of contract on the part of the contractor the Corporation reserves the right to forfeit the entire Security Deposit. Corporation also reserves the right to get the balance work executed by some other sources at the risk and cost tenderer.
- 22. All rules and regulations government the Dredging Corporation of India limited will be applicable.
- 23. If as a result of any post audit, any amount is found to be recoverable from the tenderer, the same will be recovered first from any sum due to tenderer against any current bill of the tenderer and/ or from their security deposit and /or from any other amount due from the corporation and /or on demand.
- 24. All claims of the Dredging Corporation of India Limited against this contractor or any other transactions whatsoever will be recovered from the amounts due to the tenderer under this account.
- 25. If the tenderer makes default in proceeding with the due diligence, due to lack of resources or organization or work operated is not up to the expected standards, the Corporation reserves right to cancel the contract 3(three) days notice at any time during the currency of the contract. If the tenderer fails to execute the work as conditions of the contract the Corporation reserves the right to cancel the contract and to get the work executed through other agencies at the risk and cost of the tenderer. The Corporation would be entitled to withhold any sum due and payable to the tenderer towards the sum as a result of the said breach of default. The contractor will not have any claim for compensation or otherwise on this account.
- 26. The tender is non-transferable and if transferred, is liable for rejection.
- 27. **ARBITRATION**: In case of dispute between DCI and Private Party for contract up to Rs.10 Crores the issue will be referred to Director (Operations & Technical), Dredging Corporation of India Limited and the decision of the Director (Operations & Technical) shall be final, Conclusive and binding on all the parties to the contract upon all question relating to the meaning of the specifications, designs, drawings and instructions and as to the quality of workmanship, or materials used on the work or any matter arising out or relation to the specifications and instruction concerning the works or the execution or failure to execute the same arising during the course of work. The above shall not be subjected to arbitration and in no case shall the works be stopped consequent on such a dispute arising and the work shall also be carried out by the contractor strictly in accordance with the instructions of the Director (Operations & Technical).

Any dispute or difference arise between the DCI and the contractor in connection with this contract, or as to the rights and liabilities of the parties hereto other than those referred to in above or on matters which are stated to be final and binding on the contractor shall be referred to the arbitration by a sole Arbitrator, a person to be nominated and appointed by the Managing Director, Dredging Corporation of India Ltd., Visakhapatnam and the award of the sole Arbitration shall be final and binding upon the parties hereto, subject to the provisions of the Arbitration and conciliation Act, 1996. The Arbitrator shall give a reasoned award and it shall be in accordance with the provisions of the Arbitration and conciliation act, 1996 or any statutory modifications or re-enactment thereof. The venue of the Arbitration shall be Visakhapatnam, and the courts at Visakhapatnam shall have exclusive jurisdiction on all matters with reference to this contract.

- 28. The tenderer will furnish a certificate that h is not related to any officer of Dredging Corporation of India Limited of any officer of the rank of Asst. Secretary or above in the Ministry of Shipping, Government of India. The tenderer should give a declaration along with their tender about the names of the relatives, who are employed in Dredging Corporation of India limited. Proforma of declaration attached.
- 29. Canvassing in connection with tenders is strictly prohibited and the tender submitted by the contractor who resorts to canvassing will be liable for rejection.
- 30. Tenders, which do not fulfil or any of the above conditions or are incomplete in any respect, are liable for summary rejection.
- 31. The work will be commenced and complete as per the time schedule mentioned. In the event of delay in commencing the subject work, as stipulated in the work order issued to the party will be cancelled and SD will be forfeited.
- 32. If the tenderer fails to complete the work, DCI reserves the right to execute the work from the other sources at the risk and cost of the tenderer and SD submitted will be forfeited.
- 33. No claim for the increase in the rates of the materials and labour during the contract period will be entertained by DCI.
- 34. Post-tender negotiations are banned, except in the case of negotiations with L-1 (i.e. lowest tenderer).
- 35. In case the tenderer fails to execute and complete the works within the stipulated period, liquidated damages @ 1% per week or part thereof up a maximum of 10% of the contract value for delay in the completion of work will be levied.
- 36. The security deposit will be submitted before award of the work. The EMD of successful tenderer will b converted as part of the security deposit and the same will be returned after successful completion of the contract. During the above period, the tenderer will rectify, defects, if any found at his cost.
