- 1. Sealed Tenders in single cover bid system are invited from the contractors to carry out procuring and installations of "CARRIER" 03 no. split ACs (02 nos. split AC Two Ton each Model No. EMPERIA NEO+ 3 Star and 01 no split AC One Ton, Model No. EMPERIA NEO+ 3 Star) at DCI new project office premises at HPSU Building covered area ground floor, Town ship Haldia and buy back of 13nos old ACs (12 nos. window and 01 no split)".
- 2. The tender documents shall be carried out strictly as hosted in our website http://www.dredge-india.com,Central Public Procurement Portals http://www.eprocure.gov.in and http://www.tenders.gov.in. No addition, editing, deletion of matter shall be permitted. If such action is observed at any stage, such tender will be rejected.
- 3. An Earnest Money deposit [EMD, (No exemption on EMD)] of Rs. 5,000/- (Rupees Five thousand only) has to be deposited through NEFT/RTGS to the DCI mentioned current account. If it is found on examination of a tender that there is a discrepancy between the total amount inserted in the Bill of Quantities and the amount arrived at by valuing the quantities set out there in and the rates and prices set against them, by the tenderer, calculation for the total amount will be made on the basis of Unit Rates multiplied by quantities.
