- 2) Price Bids of the technically qualified bidders shall only be opened.
- 3) No further correspondence in this regard will be allowed.
- b. Offers submitted vide FAX/EMAIL shall not be considered.
- c. Tender shall be opened on 16.09.2020 at 15:30 Hrs on the due date for tender opening.
- d. Any revision of rates after opening of the tender will not be accepted.
- e. The offer should be kept open for acceptance for six months from the date of opening of the tender.
- f. Only basic rates shall be quoted in the BOQ sheet. The terms of price (viz., FOB) (Details of other relevant charges shall be strictly mentioned in the BOQ separately, failing which will be presumed that the rates have been offered inclusive of all taxes, duties and other charges.
- g. GST as applicable shall be payable extra wherever applicable. The Percentage of tax and duties prevailing should be indicated separately failing which it will be considered as the rates are inclusive of all taxes and duties. We do not have Sales tax declaration form 'C' or 'D'.
- h. Delivery of the materials required within 4 weeks from the date of purchase order.

Guarantee/Warranty period of the product should be specified.
- 12. After award of purchase order, if the supplier fails to complete in full or any part thereof within the prescribed delivery period, the Corporation reserves the right:
