4. Bid should be signed by bidder(s) himself/ themselves or a person duly authorized on his / their behalf.
5. Main Sealed Envelope shall be the Technical Bid and the cover shall be super scribed as “Tender for Disposing of old scraps / unused / unserviceable items of WRO-Mumbai office on ‘as-is-where-is basis” – Technical Bid”. The Main Sealed Envelope i.e. Technical Bid shall contain inside another sealed envelope superscribed “Price bid” having duly signed & filled Price Bid format (Annexure-II) in it.

 17. The successful bidder would be awarded the work order for removal/lifting the Scrap and shall remit the sale amount on accepted rates of the scrap items before taking delivery of the same.
 18. The awardees should remove all scrap items at their own cost from DCI Vashi office & Quarters at JNPA Township, Uran with a proper Gate Pass during working hours within 10 days from the date of Order/information.
 19. All statutory payments, like minimum wages prescribed, compensation in case of accident or loss, etc., to the workers employed by the bidder for the removal of the items shall be borne by the bidder.
